- A. New Business
 - Brad Dull Jr. Modular trailer conditional use permit- Dull Jr. didn't actually want a conditional use permit, but plans to put a manufactured home on a cement slab. Board didn't think they could put directly on slab and would need to be on a basement, not approving directly on cement slab. Clerk followed-up with zoning and it is okay for them to have a manufactured home on a cement slab without being up in the airnothing board can do.
 - Shady bridge update & possible action- Rossing working with Jewell from Spring Green. Motion by Jon to have Jewell fill our LRIP funds to help pay for Shady- including bridge- second by Maly.
 - Kinney Lane update with action-Rossing working with landowners and land owners seem okay with returning the road to them so we don't have to replace the bridge. Laeseke checking on how the road was placed with town to determine how to best return the road.
